Topics presented and discussed will include: Proven Leadership (Management by Leadership); Liability Issues for Law Enforcement Managers, (including Legal Aspects of Employee Disciplinary Procedures); Survival Mindset; Character Driven Success; and other subjects. Individual presentations, with a lot of class participation, are the standard for instruction.

Participation in the Conference is limited to those occupying administrative, management, supervisory, or advisory positions in any Law Enforcement or Public Safety Agency. Space is limited, and due to the popularity of this program, registrations will be confirmed on a first received basis.
